We made those commitments again in August 2022 church meetings – to monitor, share, and adjust decisions.

Additional information has come to light – information that Bobby had since

September 2020, that he did not share with the rest of the overseers as we

At the South Grove team meeting on July 10, 2022, Bobby relayed to you

evaluated the situation in July, August, and September 2022, and that I learned of in February 2023 from a source other than Bobby. In a 45 minute phone call that I had with Bobby on March 20, 2023, he confirmed the truth of the information and that **he has known since September 2020**. While I'm no longer in a position to make any decisions for South Grove, I still made a commitment to you that I am constrained to honor.

I have patiently afforded the opportunity (thirteen weeks, and three team

meetings) for Bobby to share the information with you himself. I understand that

he shared this with a limited selection of chosen people, though I do not know who among you is chosen to know or not know. I have encouraged him to share it at team meeting (the same way as his July 2022 disclosure) and expressed my disappointment that he has not. I asked Bobby, and he told me that he does not intend to tell the whole church about this. I committed to you to monitor, share, and re-evaluate as new information comes out. This is not an effort to stir up division, but rather an effort to keep my commitment to you and to ensure that you are equipped with the truth. I have made an effort to have Bobby share it with you. He acknowledged to me that he also made the commitment, but has decided against providing all of you with the information.

While it was less severe than the criminal sexual assault of a minor in the 1980s, Steve Morgan felt (rightly) that his conduct in 2007 was worth confessing to all of the lead pastors in September 2020 at the same time that he confessed his

been carried out by the board of overseers at Blue Sky Church, but the Vice President of that Board was not told about the incident (until at least 13 years later), and thus we must conclude that no discipline was undertaken since a key member of the board was uninformed.

In July 2022, had I known what Bobby knew, my analysis and conclusions about Steve's qualification would have been different. I relied heavily on the assurances that "there has been nothing else," assurances offered by Bobby, Steve Morgan, and the Network Leadership Team. Those assurances were not true. I relied heavily on the assurance from the Network Leadership Team and all of the lead pastors that Steve "has continued to walk in character, integrity and purity since he became a follower of Jesus and a leader in the church." Steve Morgan's episode at Snow Lake in 2007 is not consistent with the claim that he

Jesus. The pastors who gave us those assurances were not honest with us.

I feel strongly about telling the truth, and not just to a select few, but to everyone to whom incomplete or misleading information was given in July 2022.

Scripture places a high premium on truth. In both the Old and New Testaments,

God's people are enjoined to speak the truth (Psa. 15:2; Prov. 12:17; Zech. 8:16;

Eph. 4:15, 25). The ninth commandment (Exod. 20:16) is expressly concerned

has walked in character, integrity, and purity since he became a follower of

with truthfulness, primarily in the context of a law-court (Deut. 19:15–21) but by extension in all spheres of life. As the rest of Scripture makes clear, truth-telling is a moral duty and honesty is a moral virtue. The pursuit of justice depends crucially on truthfulness, and thus the righteous are those who "love truth" (Zech. 8:16–19; cf. Amos 5:10). A sincere concern for truth should permeate not only our speech but our very thoughts (Phil. 4:8).

What you do with this information is up to you, but I feel constrained to honor my commitment to you that I would continue to monitor the situation and supply additional relevant information that surfaced.
